

# **"QUICK QUACK LOVELAND SOCIAL MEDIA" SWEEPSTAKES**

## **OFFICIAL RULES**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

1. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of Utah who are 18 years of age or older and live within 75 miles of the Loveland Living Planet Aquarium located at 12033 Lone Peak Pkwy, Draper, Utah at the time of entry. You need not be present to win. Employees (and their immediate families or those living in the same household) of Quick Quack Car Wash Holdings, LLC ("**Quick Quack**" or "**Sponsor**"); and its affiliates, subsidiaries, divisions, parent and related companies are not eligible to enter or win.
