

"QUICK QUACK LUCKY DUCK" SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of Texas who live within 75 miles of the University of Texas At Arlington located at 701 S. Nedderman Dr., Arlington, Texas, who are 18 years of age or older at the time of entry. You need not be present to win. Employees (and their immediate families or those living in the same household) of Quick Quack Car Wash Holdings, LLC (“Quick Quack” or “Sponsor”); and its affiliates, subsidiaries, divisions, parent and related companies are not eligible to enter or win.
