

QUICK QUACK LUCKY DUCK CONTEST

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **ELIGIBILITY:** This Contest is open only to legal residents of Texas, who are 18 years of age or older at the time of entry. You need not be present to win. Employees (and their immediate families or those living in the same household) of Quick Quack Car Wash Holdings, LLC (“Quick Quack” or “Sponsor”); and its affiliates, subsidiaries, divisions, parent and related companies are not eligible to enter or win.

You may be required to provide some or all of the following information: your name, age, address, city, state, zip code, telephone number, and e-mail address. 3. **ENTRY CONTENT GUIDELINES:** Your submission must include the information in the “How to Enter” section above and your guess of how many ducks are in the bin.

4. **PRIZES AND APPROXIMATE RETAIL VALUE:** There will be one (1) “Prize Winner” awarded. The “Prize” is a month of free Ceramic Duck car washes. The approximate total retail value of the Prize is \$35.99. If a Prize Winner is unable to redeem the prize within 60 days of notification, the prize will be forfeited without any compensation to the Prize Winner and an alternate Prize Winner will be selected. All other expenses not specifically mentioned are not included in the Prize.
